- ▶ 1. Declaring an Energy Emergency.
- ► This Executive Order (EO) declares a national energy emergency under the National Emergencies Act (NEA), asserting that the US energy supply is "far too inadequate," citing economic and national security concerns.

≥ 2. Unleashing American Energy.

- ▶ This EO outlines policy priorities including increasing domestic fossil energy and critical minerals production.
- ► Requires agencies to review existing regulations and suspend, revise, or rescind any that are identified as barriers to domestic "energy" development.
- Rescinds Biden-era orders related to energy and climate policy, calls for reforms to the permitting process, directs expedited review of liquefied natural gas (LNG) projects, and more.

▶ 3. International Environmental Agreements.

- ► This EO orders the US ambassador to the United Nations to withdraw from the Paris Agreement under the United National Framework Convention on Climate Change (UNFCC), and
- Revoke any financial commitments previously made by the US under the UNFCC.
- ▶ Implies immediate withdrawal but the process takes one year.

▶ 4. Alaska's Resource Potential.

- ► This EO directs agencies to support development and extraction of oil, natural gas, timber, and mineral resources in Alaska, including
- ▶ Oil and gas leasing in the Arctic National Wildlife Refuge and the National Petroleum Reserve
- ► Expedited approval of the Alaska LNG project on Alaska's North Slope.

▶ 5. Wind Energy.

- ► This memorandum withdraws the Outer Continental Shelf from wind energy leasing, and
- ▶ Pauses federal leasing and permitting of onshore and offshore wind.

Reversing Environmental Justice Policies

- A series of EOS and other actions that
- Cut off funding for climate and EJ programs;
- Effectively close all offices and terminate all employees with environmental justice functions;
- Rescind 1994 EO directing federal agencies to identify and address effects of federal programs and policies on minority and low-income populations;
- Rescind Justice 40 program directing funds to disadvantaged communities;
- ▶ Remove the Climate and Economic Justice Screening Tool from government websites.

Federal Funding Whiplash

- Office of Management and Budget (OMB) on 1-27-2025 issued a memo directing all federal agencies to begin a review of all funding, and "pause" all grants, loans, and other financial assistance.
- ▶ Amid an explosion of opposition, litigation and confusion, OMB quickly rescinded the memo.
- ► Chaos continues to reign—conflicting directives, court injunctions, uncertainty.

- ► EPA Administrator Lee Zeldin announced the overhauling of the "Endangerment Finding," a 2009 rule that declared greenhouse gases constitute a threat to public health and human welfare under the Clean Air Act.
- ► The reconsideration of this finding will involve a massive overhaul of the regulations established under this rule, including vehicle emissions rules,

► UNLEASHING AMERICAN ENERGY

▶ Reconsideration of regulations on power plants (Clean Power Plan 2.0); on the oil and gas industry; Mercury and Air Toxics Standards; Greenhouse Gas Reporting Program; on the Steam Electric Power Generating Industry; wastewater regulations for oil and gas development; and the Risk Management Program rule.

- LOWERING THE COST OF LIVING FOR AMERICAN FAMILIES
- Reconsideration of light-duty, medium-duty, and heavy-duty vehicle emissions regulations; the Technology Transition Rule; Particulate Matter National Ambient Air Quality Standard; National Emission Standards for Hazardous Air; Overhauling the "Social Cost of Carbon;"
- Redirecting enforcement resources to EPA's core mission to relieve the economy of unnecessary bureaucratic burdens (Enforcement Discretion)

► ADVANCING COOPERATIVE FEDERALISM

- ► End "Good Neighbor Plan" which led to the rejection of State Implementation Plans;
- Work with states and tribes to resolve backlog with State and Tribal Implementation Plans;
- Reconstitute Science Advisory Board and Clean Air Scientific Advisory Committee;
- Expedite state permit reviews and update coal ash regulations.
